Personal data that we process

Hansen Marine B.V. processes your personal data because you use our services and? or because you provide them yourself. Below is an overview of the personal data we process:

-First and last name.

-Address data.

-Phone number.

-E-mail address.

Special and / or sensitive personal data that we process

Our website and / or services does not intend to collect data about website of visitors under the age of 16. Unless they have permission from parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advice parents to be involved in the online activities of their children, to prevent data about children from being collected without parental consent. For what purpose and on what basis we process personal data

Hansen Marine B.V. processes your personal data for the following purpose:

-Handling your payments.

-Sending our newsletter and / or advertising brochure.

-To be able to call or e-mail you if this is necessary to be able to perform our services

-To inform you about changes to our services and products.

-To deliver goods and services to you.

-Hansen Marine B.V. also processes personal data if we are legally obliged to do so, such as information that we need for our tax return.

Automated decision making

Hansen Marine B.V. does not make decision based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without involving a person (for example, an employee of Hanen Marine B.V.) is in between.

How long do we keep personal data?

Hansen Marine B.V. does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. We use a retention period of seven (7) years.

Sharing of personal data with third parties

Hansen Marine B.V. provides data to third parties only if this is necessary for the performance of our agreement with you or to comply with a legal obligation.

Cookies, or similar techniques, that we use

Hansen Marine B.V. does not use cookies or similar techniques.

View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent for data processing or object to the processing of your personal data by Hansen Marine B.V. and you have the right to data being transferred. This means that you can submit a request to us for the personal data that we hold about you in a computer file to you or another organization specified by you. You can request access, correction, deletion, data transfer from your send personal data or request cancelation of your consent or objection to the processing of your personal data to info@hansenmarine.nl.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make in this a copy of your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black. This to protect your privacy. We will respond to you request as soon as possible, but within four (4) weeks. Hansen Marine B.V. would also like to point out that you may use the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
